The 2024 CWELCC Fee for eligible children is a 52.75% reduction of the 2022 fee (to a minimum of \$12 per day).

Note: Enrollment Fee \$75.00 per family. This fee will not be accepted unless a spot can be guaranteed. Fee will be reimbursed to the family after one month full time enrollment through credit to the second month fee or full return.

Fees are paid monthly at a daily rate. Payments are made by Pre-Authorized Debit (PAD) which is entered at least 3 business days prior to the 1st of the next month. Please see the Supervisor to make arrangements. A monthly invoice for the calendar year will be provided to the family upon enrollment.

\$20.00 NSF Charge For any NSF payment. Any family having two NSF PAD payments will be required to pay by certified cheque. There will be a \$20.00 Late fee if fees are paid after the 10th of each current month.

No Refunds For holidays, sickness, absence, weather related closures or withdrawals without notice.

Outstanding fees are to be paid by the first day of the following month. Child/ren are withdrawn until all fees are paid in full (previous month current month).

One Month Notice is required in writing for withdrawals, otherwise two weeks full fee will be charged.

NOTE

Both Centres have a Purchase of Service Agreement (fee subsidy) with Toronto Children's Services.

Income tax receipts are issued annually in February for the previous year.
